**Dr. Sébastien Boussois** holds a diploma in International Relations and a Ph.D. in Political Sciences (The University of Paris - West Nanterre). He specializes in the following fields of study: societies of the Arab world, democratic transitions in the Middle East and the Israeli-Palestinian conflict (history, water, society, intellectual landscape). He has taught at the Business School of Rouen and has been associated with the Centre Alberto Benveniste (Paris), the Free University of Belgium (REPI) and the Centre Jacques Berque (Rabat). He currently serves as a scientific advisor to the Institute MEDEA in Brussels. In 2010, he created the CCMO (The Circle of Researchers on the Middle East) in Paris, of which he is the president.

**Dr. Didier Boutet** is a lecturer and researcher at the University of Tours (France).

**Dr. Jean-Paul Burdy** is an associate professor of history at l'Institut d'études politiques (IFP) in Grenoble, where he lectures primarily in the political history and geopolitics of the geographical zone covering Turkey-Iran-the Caucasus-the Persian Gulf-the Middle East. As a researcher, he is also associated with GREMMO in Lyon. His works include: *La Turquie est-elle européenne? Contributions au débat* (Levallois-Perret, Editions Turquoise, 2004), and "La Turquie candidate et le génocide des Arméniens: entre négation nationaliste et société civile," in *La Turquie face à l'Europe* (Montpellier, CERVL, 2005).

**Dr. Giulia Daniele** currently serves as a research fellow in Political Science at the Sant'Anna School of Advanced Studies (SASAS), Pisa. After obtaining her B.A. in International Studies (2005) and an M.A. in International Relations and Human Rights (2007) at the University of Turin, she completed her Ph.D. under a co-tutelage agreement between the SASAS and the University of Exeter in April 2012. Since 2005, she has conducted fieldwork research in the West Bank, the Gaza Strip, Israel and Tunisia, focusing on Middle East politics (in particular, the Israeli-Palestinian conflict) and women's political activism in the MENA region. Her first book is entitled *Women, Reconciliation and the Israeli-Palestinian Conflict: The Road Not Yet Taken* (Routledge, 2014).

Mr. Ali Fathollah-Nejad is a German–Iranian political scientist. He has studied in Germany (Münster), France (Sciences-Po Lille), and the Netherlands (Twente). Last year, at the London School of Oriental and African Studies (SOAS), he submitted his Ph.D. thesis on Iran's international relations in the 2000s against the backdrop of a changing world order. He has also been a visiting lecturer on Globalization and Development in the Middle East at the University of Westminster. The author of two monographs on the U.S.–Iran conflict, he has published over 70 pieces in English, German and French, which have been translated into a dozen languages (including Czech).

**Prof. Alia Gana** is a trained sociologist currently serving as a directress of research at CNRS. She has been associated with CNRS since 2003. Her research interests include, among other things: social systems of agriculture, the rural milieus, local development, environment and sustainable development and the administration of communal property. Her publications include: *Inégalités et risques face à la gestion de la ressource hydraulique en Méditerranée* (with J-P. Billaud, L'Harmattan, 2011), "Micro-entreprises féminines, gestion des ressources naturelles et lutte contre la pauvreté rurale en Tunisie. Exemple du projet de développement du bassin-versant de Oued Sbaïhya (gouvernorat de Zaghouan, P-N. Denieuil)." In *Les entrepreneurs maghrébins* (Khartala, Paris, 2011) and many others.

**Dr. Ali Granmayeh** studied Law and Political Science at the University of Tehran and obtained a Ph.D. in International Relations from the University of London. He served at the Iranian Ministry of Foreign Affairs and was assigned to various diplomatic positions abroad. Later on, he became a lecturer at the University of London, and was also a research associate (1992-2012) at the CNMES/LMEI, SOAS, and the University of London. He has published articles and book reviews in the Slavonic Review, the Maghreb Review, RUSI, and elsewhere. He is a frequent contributor, as an analyst and commentator, to the BBC, VOA, DW, RFE/RL and other media networks.

**Ms. Gamze Hakverdi** received her master's degree from Hacettepe University, Ankara, the Faculty of Communications. Her thesis, which was eventually published as a book entitled *Water, Fog and Earth: Film-Images of New Turkish Cinema* (2013), discusses the aesthetical aspects of new Turkish cinema in terms of the collective visuality. Presently, as a Ph.D candidate, she is undertaking her field research, which utilises a visual-ethnographic methodology, regarding the ideological gaze formations between locals and immigrants in Rome, Italy.

**Ms. Zora Hesová** is a researcher associated with the Association for International Affairs in Prague. She has published numerous articles in Czech and regularly comments on the MENA region for the Czech media.

Ms. Tereza Jermanová holds a B.A. in Political Science from Charles University, Prague, and an M.A. in North African politics from the University of Exeter. She has also studied at Science Po, Paris. Ms. Jermanová is a research fellow at the Association for International Affairs and regularly writes commentaries and gives interviews to the Czech media. In 2011, she co-coordinated a project focused on the training of Egyptian journalists in electoral coverage. Her main research interests relate to the problems of transitions, institutional design and politics in Egypt. Currently, she is in charge of a project comparing the constitution-making processes in Egypt and Tunisia after 2011.

Mr. Akram Kachee is a specialist on Syria and is associated with GREMMO, Lyon.

**Prof. Henry Laurens** serves as Chair of History of the Contemporary Arab World at the Collège de France, in Paris. He obtained higher degrees and distinctions in history, and studied literary Arabic at the INALCO. He has published many books, among them *Les Origines intellectuelles de l'expédition d'Égypte* (1987), *Paix et Guerre au Moyen-Orient* (1999), *L'Orient arabe à l'heure américaine* (2004) – which has just been translated into (2013).

**Dr. Didier Leroy** serves as a researcher at the Chair of Sociology of the Royal Military Academy of Belgium (RMA) and is a part time assistant professor on the Master's degree course in Population and Development Sciences at the Free University of Brussels (ULB). He is also a scientific collaborator for the CECID (the Centre for the Study of International Cooperation and Development) of the ULB. In addition, he is a member of the Board of the Circle of Researchers on the Middle East (CCMO) and an associate researcher at the Observatory on the Middle East and North Africa (OMAN) at the University of Quebec at Montreal (UQAM).

**Prof. Jean Marcou** currently serves as director of International Relations at l'Institut d'études politiques (IFP) in Grenoble. At IEP, he supervises a Master's degree programme on the Mediterranean and the Middle East. His principle research field addresses the evolution of political equilibrium in the Middle East, with an emphasis on Egypt and Turkey. Between 2000 and 2006, he served as director of the francophone section of the Faculty of Economics and Political Sciences, the University of Cairo. He also directed l'Observatoire de la Vie Politique Turque (OVIPOT) during 2006-2010. His works include: *La Nouvelle Egypte, idées reçues sur un pays en mutation* (Le Cavalier Bleu, 2013) and *Vingt ans de changement en Turquie* (1992-2012) (Paris, L'Harmattan, 2013), with Türkmen Füsun.

**Prof. Firouzeh Nahavandi** is a professor at the Free University of Brussels (ULB), where she directs the Centre for Studies in International Cooperation and Development (CECID). She is a member of, l'Académie Royale des Sciences d'Outre-Mer de Belgique and an associate professor at several overseas universities. Her recent publications include: *L'Iran dans le monde* (L'Harmattan, 2013), *Iran* (De Boeck, 2013) and *Afghanistan* (De Boeck 2014).

**Dr. Mamduh Nayouf** holds a Ph.D. in Arab and Islamic studies from the University of Michel de Montaigne, Bordeaux, and an M.A. in Political Sciences from the University of Latakiya. His research interests include US foreign policy in the MENA region and the economic structure of Arab countries. Among his publications, we may mention *De Bush à Obama: quel changement de politique américaine au Moyen-Orient?* (to be published by l'Harmattan in 2014).

Ms. Deborah Perez holds a Master's degree in Social Sciences from the EHESS and a Master's degree in Public Affairs from Sciences Po (2012). A student of the Ecole Normale Superieure (Ulm), she focuses on the political practice of the members of parliament in post-revolutionary Tunisia. She developed an interest in the MENA region after completing a B.A. in English literature and history (2008) and following an exchange programme at King's College, London (2008-2009). She has interned in several public and private institutions and leads a seminar on the contemporary history of the MENA region (2013-2014) at the ENS, Ulm.

**Dr. Marie Vannetzel** is a post-doctoral researcher at CERI, Paris, on the ERC programme "When Authoritarianism Fails in the Arab World" (WAFAW), coordinated by François Burgat and Laurent Bonnefoy.
